
 MARTA owns and maintains 104 miles of continuous welded rails on our Mainline tracks with and additional 20 miles of Yard tracks.

 MARTA's Track and Structures branch visually inspect Mainline and Yard rail twice weekly.

 MARTA contracts ultrasonic inspections of its mainline running rails twice each year per industry best practices. Ultrasonic inspections detect internal rail flaws that are not visible to the naked eye.














The ultrasonic non-destructive testing method is the most frequently used in the industry.

Ultrasonic waves are transmitted into the rail at various angles - from the top of the rail head through the web to the bottom of the rail and the entire width of the rail head.

Many rail defects show no visible sign of failure in the early stages of progression.


This bolt-hole crack was covered by a joint bar and therefore not visible but discovered via ultrasonic testing.

# **Operation Resolve Scope**


- Mission Area(s)
  - Response
- Core Capabilities
  - Logistics and Resource Management
  - Operational Communications
  - Operational Coordination
  - On scene Security and Protection
  - Public Information and Warning





# Objectives

- Evaluate the capabilities to establish lines of communication, allocate resources and maintain a common operating picture between first responders.
- Evaluate the use of existing MARTA plans, policies, and procedures while integrating all necessary MARTA departments and external partners in response to a potentially terrorism-related incident.
- Evaluate the capability to ensure security of the MARTA right of way, public, and responders within affected areas.
- Evaluate the capability to share and disseminate internal warnings and emergency public information
- Situational Assessment



# Threat or Hazard Scenario

- Threat- active threat, hostage rescue, rail rescue, civil disturbance
- The exercise contained multiple scenarios to allow for responders to test their skills, including:
  - Hostages taken on a bus.
  - Protestors inside a station upset over recent efforts to clear trees out of the right of way.
  - Passengers unable to evacuate a rail car located partially inside a tunnel.
  - Incident Command managing multiple incident responses.




# After Action Report
