**Public Comment** 

Mr. Matthew Perry. We are interested in affordable, equitable accessible transportation.

Dr. Joanne Rhone. My concern and the concern of my neighbors is the renaming of the MARTA West End Station. I wrote a letter to the President of the Board upon learning of the name change and met with staff. She reviewed MARTA's policy on the naming and renaming of stations and found it to be very broad. The last response I received was the Committee of the Board is working on a policy. The last response to questions about the policy was that it was passed to the Legal Department. We want the Board to rescind the renaming of West End Station. We want the name to remain West End.

Ms. Kay Wallace. Like Dr. Rhone, I am a long-term resident of West End. I was here about four months ago. In 2001 the Board decided to rename West End Station, Abernathy. In 2007 it came up again. And now in 2018, here we are again. We understand honoring the Abernathys. Please do not dishonor our community at the same time. We have suggested things that can be done at the stations, rail cars and buses. We have a community that predates Atlanta, a community that has a brand and an identity. We are one of the most walkable communities in Atlanta and one of the most transit accessible communities. There is no reason to rename West End. Today you will be presented with a petition from the West End community. There is an article in today's AJC. We would like you to rescind your decision.

Mr. Steve Williams. Live in Capitol View near the Oakland City MARTA Station. The elevator on the Murphy Street side has not been operable for 33 years. A 200-person senior center was recently built. Several years ago, we were told the senior center was going to be build and MARTA would put in an elevator at the station. A second elevator was supposed to be put in this past summer. Nothing has been done.

Ms. Brenda DuBose. Live in an elderly community at 700 Atlanta Avenue. We have a problem accessing the Decatur Station. The community need a bus that will come closer to the community. A lot of the residents are in wheel chairs. Please consider reopening #2 Ponce bus and the #123. The community need this service.

Mr. Guy Seymour. Also, a resident of 700 Atlanta Avenue. The building is at the top of a hill. We have issues accessing the bus stop. We need a bus that comes up to the building.

Ms. Sophia Khalid. All ADA people who are riders of MARTA should file a class action lawsuit against MARTA for lack of ADA accessibility to buses and lack of sidewalks. I have to take 2 buses and 2 trains and I almost got hit last week. There are people that have fallen off Bus 24.

Rep. Viola Davis. We have been discussing shelters and benches which should have been solved ten years ago. The signage could have been solved by now. You close the restrooms, when you're putting in Coke machines. Why would MARTA extend the tax another ten years? Look up Georgia Tea Party.com and DeKalb Tea Party.com. This is about inequity, particularly about the tax money.

Mr. Joel Edwards. Mr. John Evans sends greetings. We came before you in July to announce that DeKalb County is underserviced. There are problems with ADA, bus service, time intervals between bus arrivals, shelters and cleaning of bus stops. Some MARTA Board members are a problem because they are not representing DeKalb.

Dr. Ed Williams. There are problems with the contracts MARTA enter with the jurisdictions. Two major contracts are RTCAA signed in 1971 and a new contract with Gwinnett. The Gwinnett contract will not be a part of the RTCAA. The City of Atlanta Streetcar is not part of the RTCAA. This is unfair. Until we get equity there will be legal issues. Dr. Williams encouraged everyone to read the Contracts that MARTA have signed with the jurisdictions.

Ms. Sherry Williams. Enjoyed Ms. Allen's presentation on the Super Bowl. Ms. Williams proposed adding an express bus to Camp Creek area, stop at Barge Road parking lot and from there go straight to Oakland City. We want to ensure there is additional capacity. Also, something should be done about Hamilton Holmes.

Ms. Terri Williams. Started commuting on MARTA in December 2016. My complaints have been continuous. There are still issues with the #110. The wait time is 30 minutes to one hour.

#### Presentation

Mr. Parker recognized one of MARTA's unsung heroes, Mr. Winston Douglas.

Mr. Douglas was on his bus route and came across a situation involving a southwest Atlanta woman. He stopped his bus, de-boarded and intervened in what was a very dangerous situation. On behalf of the MARTA Board and MARTA Family, Mr. Parker presented a plaque to Mr. Douglas in honor of his heroic deed.
